WAIVER AND RELEASE OF LIABILITY

In consideration of Wilderness Safety Consultant, Russ L. Miller, furnishing instructional services and/or equipment to enable me to participate in **Swift Water Rescue** training, I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my participation in the **Swift Water Rescue** course; (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, Partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the outdoor/guide, associates, contract employees, or agents of Wilderness Safety Consultant, Russ Miller; the negligence of the participants, the negligence of others, accidents, breaches of contracts, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes, including, but not limited to, instructional decision making, including that an instructor may misjudge terrain, weather, trail or route location, and water levels, risk of falling while participating in **Swift Water Rescue** training and such other risks, hazards and dangers that are integral to recreational instructional activities that takes place in a wilderness, outdoor or instructional environment; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and or damages, weather caused in whole or in part by the negligence or other conduct of the outdoor guide, associates, or by any other person.

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Wilderness Safety Consultant, Russ L. Miller, and his respective associates, agents or others from all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of equipment or my participation in **Swift Water Rescue** outdoor training/activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for negligent acts or other conduct by the outdoor guide Russ Miller or associates.

WSC (Russ Miller) and persons designated by it/him may use my photograph for sale or reproduction in any manner WSC chooses, including for advertising display, audiovisual presentations or otherwise.
