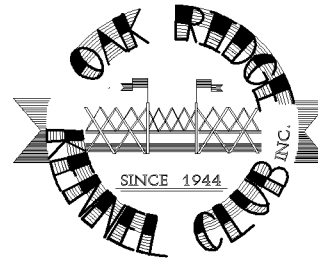

CERTIFICATION: With the entry form for a dog that has not passed an AKC TD test, there must be filed an original statement dated within one year of the test, signed by a person who has been approved by the AKC to judge tracking tests, certifying that the dog has satisfactorily performed a certification test track.

ENTRIES will be accepted only on official AKC entry forms.

DRAW: In the event the published limit is exceeded, a drawing will be held at 7:00 p.m., January 27, 2011, at 1007 Buck Creek Road, Kingston, Tennessee, and the public is invited. Entrants will be notified by phone or email promptly after the drawing is complete. Entries of AKC TD dogs will be accepted only if the test is not filled by dogs without said title. BE SURE TO INCLUDE PHONE NUMBER/E-MAIL ON ENTRY!

BITCHES IN SEASON will be allowed to run in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations.

IN THE EVENT AN ENTRANT IS ABSENT on the day of the test, it shall be the responsibility of the Test Secretary to determine if any alternates are present. If so, space will be filled by such in the order they were drawn. Entry fees and certifications will be returned within seven (7) days following the test for alternates who do not run and for entrants replaced by an alternate at the test.

In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person or any other cause or causes.

- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed.
